Rights of the data subject

- obtain the rectification and erasure of data;
- obtain the limitation of processing;
- obtain the portability of the data, i.e. receive them from a data controller, in a structured, commonly used and machine-readable format, and transmit them to another data controller without hindrance;
- to object to the processing at any time and also in the case of processing for direct marketing purposes;
- oppose an automated decision-making process concerning natural persons, including profiling.
